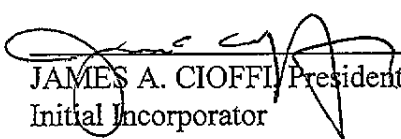
ARTICLE OF AMENDMENT

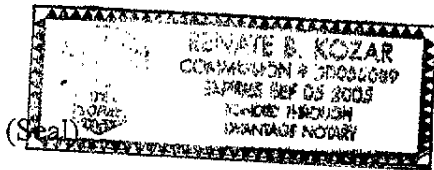
