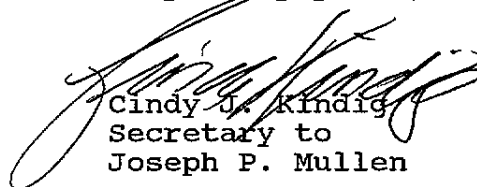

1. ARTICLE I. NAME of the Articles Of Incorporation of RITZ SAFETY EQUIPMENT, INC. is hereby amended to read as follows:

ARTICLE I - NAME

The name of the corporation shall hereafter be:

**"ENOZ, INC."**

The Principal Office of the business of this corporation shall hereafter be 2251 N.E. 44th Street, Lighthouse Point, Florida 33062.

2. ARTICLE IV. ADDRESS is also hereby amended to read as follows:
