Dear Ms. Mortham:

I enclose Reinstatement Applications for the above-named corporations as well as three (3) checks in the amount of \$315.00 for each corporation totalling \$945.00.

I would like to take this opportunity to explain the reason for the lateness in the dissolution notices which were received for all three of these corporations, and I would also like to bring to your attention that these corporations have been in good standing since 1988, 1991 and 1994 respectively.

We have had several changes in personnel over the past two years and have had a great deal of difficulty trying to overcome these adjustments. In particular, our bookkeeper, who was responsible for handling the corporations' financial needs, was not attentive to the immediate obligations/necessities of the above-referenced firms, thus, many disasters were the results of this incompetence. It was explained to the bookkeeper when hired that the corporate annual reports needed to be filed each year

and, in the past years, they were timely filed. In light of this management had no reason to believe that these reports were not filed for the year 1997. Needless to say, the bookkeeper was terminated this past November and we have been struggling ever since then to get back in the "running". We have since hired a new bookkeeper who is attentive to our needs and who is trying desperately as well as diligently to bring the firms up-to-date with all the obligations involved.

The purpose of this letter is to ask for your mercy in allowing the above-referenced firms to pay the fee of \$315.00 each without being penalized for the \$900.00 (reinstatement) for each corporation which total out to \$1,755.00, a very expensive mistake considering the circumstances that these problems occurred without the shareholders' or the management's knowledge.
