

# ARTICLES OF AMENDMENT TO ARTICLES OF STATE INCORPORATION OF WESTEROOR SERVICE CORPORATION ASSEE, FLORIDA

WHEREAS, the name of the Corporation is WESTBROOK SERVICE CORPORATION: and

WHEREAS, the Corporation was incorporated pursuant to the laws of the State of Florida effective December 27, 1988; and
