## AMENDMENT TO ARTICLES OF INCORPORATION OF STADIUM TOYOTA, INCRETARY OF STADIUM TOYOTA, INCORPORATION OF STADIUM TOYOTA, INCRESSEE, FLORIS DOCUMENT NUMBER K57591

Pursuant to the provisions of Section 607.1006, Florida Statutes, Stadium Toyota, Inc., a Florida corporation adopts the following Amendment to its Articles of Incorporation:

An Article IV(c) of the Articles of Incorporation is hereby added and reads as follows:

(c) In addition to the voting shares authorized in Article IV(a) of these Articles of Incorporation, the corporation is authorized to issue 1,000 shares of nonvoting common stock, with a par value of \$1.00 per share. The holders of these nonvoting shares of common stock shall not be entitled to any votes at an annual or special meeting of the Stockholders of the corporation.
