INCORPORATION OF TABAS, FREEDMAN, SOLOFF, MILLER & BROWN, P.A.**

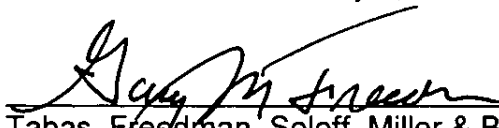
In accordance with the provisions of Section 607.1006 of the Florida General Corporation Act, the undersigned corporation hereby adopts the following:

1. The new name of the corporation shall be **Tabas, Freedman, Soloff, Brown & Rigali, P.A.**

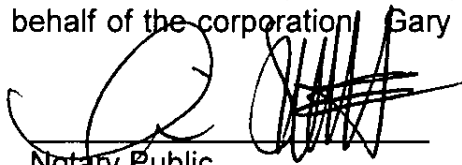

3. The Amendments were approved by the shareholders and the numbers of votes cast were sufficient for approval. The date of adoption by the shareholders was January 3, 2013.

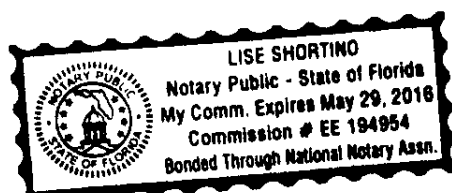
