## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE CARDIOLOGY CENTER OF PALM BEACH COUNTY, P.A.

CORPORATION OF THE SECOND STATES The following provisions of the Articles of Incorporation of THE CARDIOLOGY CENTER OF PALM BEACH COUNTY, P.A., a Florida corporation ("Corporation"), filed with the Department of State on January 17, 1989, Charter Number K58702, are hereby, amended as shown below:

The title of the Articles of Incorporation is amended by deleting the following: 1.

> "FOR PROFESSIONAL CORPORATION (FS SEC. 607,164 AND CHAPTER 621)"

The first unnumbered paragraph of the Articles of Incorporation is amended by 2. deleting it in its entirety and substituting in its place the following:

> The President of the Corporation and the original incorporator does hereby subscribe to and file these Articles of Incorporation for the purpose of organizing a corporation under the Florida **Business Corporation Act.**

Article I of the Articles of Incorporation of this Corporation is amended to read in its entirety as follows:

3. Article II of the Articles of Incorporation of this Corporation is amended to read in its entirety as follows:

11.

### **PURPOSES**

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
