*Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:*

1. Article I of the Articles of Incorporation of Simpson Lawrence USA, Inc. is amended by deleting Article I in its entirety and substituting in lieu thereof the following:

**ARTICLE I. NAME**

The name of the corporation is SIMPSON-LAWRENCE, INC.

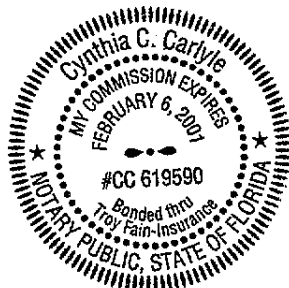
3. The foregoing Amendment was also adopted by the Board of Directors of the Corporation by unanimous Written Action taken as of January 1, 1999.


