**ARTICLES OF DISSOLUTION**

Pursuant to Fla. Stat. 607.1403, WTWB Radio Station, Inc., a Florida corporation, adopts these Articles of Dissolution for the purpose of dissolving the corporation.

**ARTICLE I**  
**NAME OF CORPORATION**

The name of the corporation to be dissolved is WTWB Radio Station, Inc.

**ARTICLE II**  
**DATE DISSOLUTION AUTHORIZED**

The dissolution of WTWB Radio Station, Inc. was authorized by written consent of the sole shareholder of the corporation, Evangel Christian School, Inc., on April 19, 1999.

**STATEMENT REGARDING APPROVAL OF DISSOLUTION**


