Pursuant to the provisions of section 607.1006, Florida statutes, the undersigned President of BSD Healthcare Industries, Inc. ("Corporation"), does hereby certify:

First: That pursuant to Written Consent of the Board of Directors and Majority Shareholders of said Corporation dated December 17, 2001, the Shareholders and Directors approved the amendment to the Corporation's Articles of Incorporation as follows:

Article 1, of the Articles of Incorporation of this Corporation is amended to read in its entirety as follows:

**Article 1**

The name of the company is "BSD Software, Inc."
