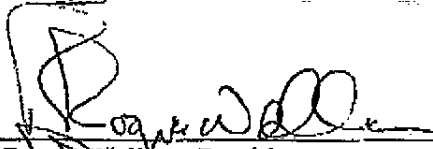
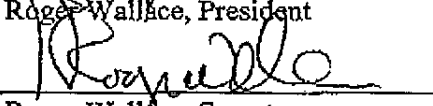

2. The foregoing Amendment was adopted by all the Stockholders and Directors of the corporation on the 20 day March, 2001.

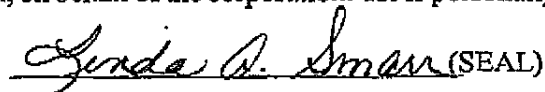

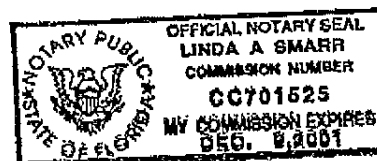
