Pursuant to the provisions of §607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

ARTICLE I  
NAME

The name of the corporation shall be **Magic Detailing, Inc.**

ARTICLE II  
NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

- a. To engage in the business of automobile detailing, cleaning and refinishing.
- b. To engage in the business of home and office janitorial services.
- c. To engage in any commercial, industrial, and agricultural enterprise calculated or designed to be profitable to this corporation.
- d. To generally engage in, do and perform, any enterprise, act, or vocation that a natural person might or could do or perform.
- e. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidence of indebtedness, and execute such mortgages, transfers of corporate property or other instruments to secure payment of corporate indebtedness as required.

The foregoing paragraphs shall be construed enumeration both objects and powers of the corporation and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this corporation.

The date of each amendment's adoption is June 13, 2000.

The amendments were approved by the shareholders. The number of votes cast for the amendments were sufficient for approval.
