



Article IV – Capital Stock of the Articles of Incorporation of TREE KING-TREE FARM, INC., was amended by the consent of the corporation's board of directors and of its shareholder March 1, 2019. The corporation is filing these Articles of Amendment to Articles of Incorporation pursuant to Section 607.1003, Florida Statutes.


1. The name of the corporation is TREE KING-TREE FARM, INC.
2. Article IV – Capital Stock of the Articles of Incorporation of TREE KING-TREE FARM, INC., was amended as follows:

The Corporation is authorized to issue Two Thousand Shares of common stock with a par value of One Dollar per share. The corporation elects to have preemptive rights. This provision may not be amended except by the affirmative vote of the holders of not less than 1850 Shares of common stock.

3. The foregoing amendment to Articles of Incorporation was duly adopted by the consent of the corporation's board of directors and of its shareholders effective on March 1, 2019.
