

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF TREE KING-TREE FARM, INC.

Article IV – Capital Stock of the Articles of Incorporation of TREE KING-TREE FARM, INC., was amended by the consent of the corporation's board of directors and of its shareholder March 1, 2019.
