ARTICLE II-MAILING ADDRESS

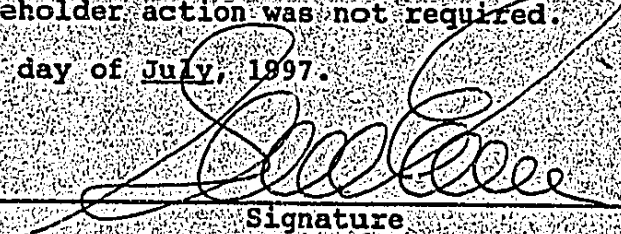
