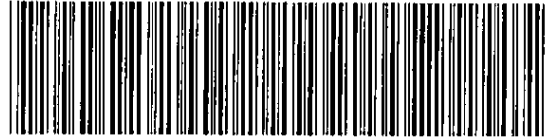

**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF
SPECTRUM VIDEO PRODUCTIONS, INC.**

Pursuant to Section 607.1006 of the Florida Statutes, **SPECTRUM VIDEO PRODUCTIONS, INC.** a Florida corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The Articles of Incorporation of the Corporation were filed on February 17, 1989 and assigned document number K67082.

SECOND: Article I of the Corporation's Articles of Incorporation is amended in its entirety to read as follows:

"ARTICLE I

NAME

The name of this corporation is **REMEDY TELEVISION + BRANDED, INC."**

THIRD: Except as expressly provided in these Articles of Amendment, all of the terms and provisions of the Articles of Incorporation shall remain in full force and effect and are ratified and confirmed.

FOURTH: The effective date is the date these Articles of Amendment are approved by the Florida Secretary of State.

FIFTH: The above amendment was adopted by the board of directors and the shareholders of the Corporation on September 24, 2019. The number of votes cast for the amendment were sufficient for approval.
