FINAL JUDGMENT OF ADOPTION

Upon consideration of the Petition for Adoption by Stepparent and upon the evidence presented, the Court finds that:

- 1) The Court has subject matter jurisdiction over the Petition for Adoption by Stepparent.
- 2) the Court has jurisdiction over the children who are now adults, subject to the Petition for Adoption by Stepparent.
- 3) The Petitioner desires the permanent responsibility of a parent in this adoption.
- 4) There is no pending litigation regarding the children in Florida or any other state nor is there any other person not a party to this proceeding that has any claims or rights relating to said children.
- 5) The consent of the birth mother and Jason Michael Walker's wife are attached to the Petition and the consent of the birth father was received by the Court at Final Hearing.
- 6) The best interest of the children will be promoted by this adoption.
- 7) The children are suitable for adoption by the Petitioner.

NOW THEREFORE IT IS ORDERED AND ADJUDGED that:

1) The parties subject to this Petition, namely JULIE MARIE WALKER and JASON MICHAEL WALKER, are declared to be the legal children of the Petitioner, KENNETH LEWIS WALKER.

2) JULIE MARIE WALKER and JASON MICHAEL WALKER shall be the children and legal heirs at law of the Petitioner, KENNETH LEWIS WALKER and shall be entitled to all rights and privileges and subject to all obligations, of children born to the Petitioner.

3) All legal relations between the adoptees and the non-custodial parent and between the adoptees and relatives of that parent are terminated by the adoption as are all parental rights and
