**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, **LAKE MARY FAMILY PRACTICE-SCOTT VANLUE, M.D., P.A.**, adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is LAKE MARY FAMILY PRACTICE-SCOTT VANLUE, M.D., P.A.
2. The original Articles of Incorporation for the corporation were filed on February 24, 1989, and assigned Charter No. K68324.
3. Article I of the Articles of Incorporation is hereby amended to read as follows:

**ARTICLE I - NAME**

The name of this corporation shall be **SCOTT VANLUE, M.D., P.A.**

4. The foregoing amendment was adopted on October 24, 2005 and the number of votes cast for the amendment by the sole shareholder was sufficient for approval.
