C. The effective date of this change of name shall be September 1, 2002.

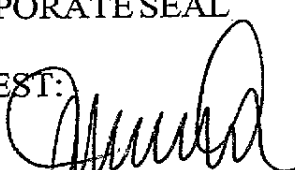
