

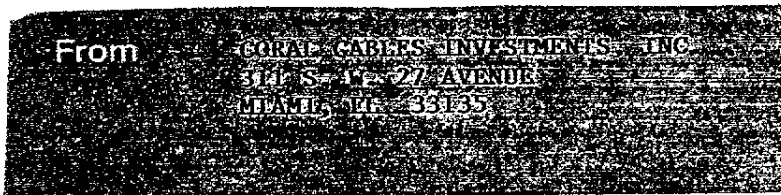

The dissolution was authorized on November 30, 1997.


ARTICLE III. APPROVAL.
