The name of the corporation is Community Investment Services, Inc. (the "Corporation").

II.

Article I of the Articles of Incorporation of the Corporation is hereby amended to read in its entirety as follows:

"ARTICLE I - NAME

The name of the Corporation is Cardinal Investment Services, Inc. (hereinafter called the "Corporation")."

III.

This Amendment to the Articles of Incorporation was duly adopted pursuant to Section 607.1003 of the Florida Business Corporation Act by the unanimous resolution of the Board of Directors and the holders of the issued and outstanding shares of Common Stock of the Corporation on January 30, 1998.
