Dear Sir,

I am writing with a request for reinstatement for Stuhl Engineering Consultants, Inc. and an explanation for the failure to register in 2003. I spoke with a lady at the 850-245 6059 number and she suggested I include this explanation with the application.

I work on a part time basis for Stuhl Engineering, primarily providing design and drafting consulting services to the company, as that is my business. However, I also do most of the basic bookkeeping work for Stuhl Engineering, when income allows for such. I am not a professional in that line of work and deal, mostly, with paying whatever bills the company receives. I have no record of having received a statement for filing with the state in 2003, although I did see, in reviewing the company's records, where I have filed in past years. Since bookkeeping is not my focus of business, I do not keep track of all the appropriate dates for filing the many forms that are required each year and rely solely on notices received concerning such. Most likely, the form was sent by the state; we may not have received it and I would never have given it a second thought.

I personally accept full responsibility for the failure to file. Were I more versed in the bookkeeping area, I would have thought of it automatically and been aware of not having received the January mailout from the state. Please consider reinstating Stuhl Engineering's corporate license. I have included the original amount due and respectfully request that you accept it as payment for 2003. If this is not possible, could we please work out a payment plan whereby I can pay the state for my mistake.
