**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
SOUTHEASTERN RADIATION PRODUCTS, INC.**

SOUTHEASTERN RADIATION, INC., a Florida corporation (the "Corporation") hereby adopts these amendments to its Articles of Incorporation as hereinafter set forth.

1. Pursuant to §607.1003 of the Florida Statutes, the Board of Directors of the Corporation and the Shareholder of the Corporation adopted, in accordance with §607.0821 and §607.0704 of the Florida Statutes, on December 17th, 2004, an amendment to Article I and to Article IV of the Articles of Incorporation of the Corporation, deleting Articles I and IV in their entirety and substituting therefor the following:

**A. ARTICLE I
NAME**

The name of this Corporation is **.decimal, Inc.**

**B. ARTICLE IV
CAPITAL STOCK**


The Corporation is authorized to issue 10,000,000 shares of common stock, one class, no par value.

2. Except as modified hereby, the Articles of Incorporation of the Corporation shall be and remain in full force and effect.

3. The number of votes cast for the amendment by the Shareholder was sufficient for approval, and the Corporation's Shareholders are not divided into different voting groups.

4. The effective date of this amendment shall be January 1, 2005.
