We have just found out that the above mentioned corporation has been dissolved. We are in the process of completing a closing on a property owned by Barefoot Cay Corporation and that is how we discovered this information.

Enclosed please find our copy of check #3209 in the amount of \$150.00 written on March 26<sup>th</sup>, 2000 along with our completed 2000 UBR. After completing my bank reconciliation in May, I noticed that this check was still outstanding. I called your office on June 7<sup>th</sup> and spoke to a Mrs. Lawrence trying to follow up as to why this check had not been processed. Mrs. Lawrence informed me that there was a delay in their processing due to computer related problems and the processing should be completed shortly. Since we never received a delinquent notice, nor a notice of dissolution we took for granted that the company was in good standing.

I am enclosing our check #3241 in the amount of \$150.00 to replace our previous check #3209 which apparently was misplaced before being processed along with a completed reinstatement form. We have five other companies which we sent in (UBR's) for at the same time and they all got processed accordingly.

We kindly ask that you review this information and the supporting documentation. We do not believe that it would be fair for us to be liable for the \$600.00 reinstatement fee when we, in good intention followed the required process.

We look forward to hearing from you as soon as possible as we need to get this matter resolved and proceed with our closing.
