1. The name of the Corporation is Florida Commercial Laundry Systems, Inc.
2. Article I, "NAME," of the Articles of Incorporation of the Corporation is hereby

amended to read as follows:

"ARTICLE I - NAME

The name of this corporation is AAXON LAUNDRY EQUIPMENT, INC."

3. The foregoing amendment was adopted by the sole Director and sole Shareholder of the Corporation eligible to vote by a Written Consent signed by them on July 1, 1999, manifesting their intention that these amendments to the Articles of Incorporation be adopted, pursuant to Section 607.1003, Florida Statutes.
