As indicated to you in our conversation in previous letters, when we sent you the 2001 Uniform Business Reports we enclosed the checks but forgot the signature.

We never received any notification from you indicating that we had forgotten the signature. And you cashed the checks. We assumed everything was in order. We never received the letter that you claim you sent us in May 2001.

When we checked and realized that registration for KLIMAIRE PRODUCTS nor ENVIRONMENTAL PRODUCTS had not been filed, we called your office. We were told that the corporations were not filed because documents were not signed. We told you to send us the documents.

We are also enclosing two new Corporation Reinstatement Forms, with two check Check 1257 for \$158 for Environmental Products and Check 5758 for \$158 for Klimaire, applicable to Corporation Registration and Certificate of Status, for the years 2002 for KLIMAIRE PRODUCTS and ENVIRONMENTAL PRODUCTS.
