ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SKELDING, LABASKY, CORRY, EASTMAN, HAUSER, JOLLY & METZ a Professional Association

Pursuant to Section 607.1006, Florida Statutes (1997), the Articles of Incorporation of Skelding, Labasky, Corry, Eastman, Hauser, Jolly & Metz, a Professional Association, organized and existing under the laws of the State of Florida, are hereby amended as follows:

ARTICLE I is amended to read as follows:
 The name of the professional service corporation is Skelding, Labasky,
 Corry, Hauser, Jolly, Metz & Daws, a Professional Association.

ARTICLE IV is amended to read as follows:

2.

- The capital stock of the professional service corporation shall be 19,000 shares of Class "A" common stock having a par value of \$1.00, and 3,800 shares of Class "B" common stock having a par value of \$1.00. Class "B" stockholders shall not have the right to vote on amendments to these Articles of Incorporation, and shall not have the right to vote on compensation paid to employees who are Class "A" stockholders.
 - None of the shares of the professional service corporation may be issued to anyone other than an individual duly licensed to practice law in the State of Florida.
- 3. Except as above amended all provisions of the said Articles of

Incorporation shall remain in full force and effect.

The foregoing amendments were approved and adopted by a majority vote of all of the shareholders and all of the members of the Board of Directors of Skelding, Labasky, Corry, Eastman, Hauser, Jolly & Metz, P.A, on October 28, 1997 and on December 30, 1998.
