

Pursuant to Section 607.1006, Florida Statutes, (2001) the Articles of Incorporation of Skelding, Labasky, & Cox, a Professional Association, organized and existing under the laws of the State of Florida are hereby amended as follows:

1. ARTICLE I is amended to read as follows:

The name of the professional service corporation is **Skelding & Cox**, a Professional Association.
