**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
FRESE, HANSEN, ANDERSON, ANDERSON, HEUSTON & WHITEHEAD, P.A.**

Article I of the Articles of Incorporation of FRESE, HANSEN, ANDERSON, ANDERSON, HEUSTON & WHITEHEAD, P.A. (the "Corporation") was amended by the Corporation's Shareholders on April 17, 2017. The Corporation is filing these Articles of Amendment to Articles of Incorporation pursuant to Florida Statutes Section 607.1006.

1. The name of the Corporation is FRESE, HANSEN, ANDERSON, ANDERSON, HEUSTON & WHITEHEAD, P.A.
2. The Articles of Incorporation were filed with the Florida Department of State on April 19, 1989.
3. Article I of the Articles of Incorporation of the Corporation shall be amended to read as follows:
