As a follow-up to your telephone conversation today with my assistant Kim, and in connection with the reinstatement of the above Corporation, we have enclosed an Application for Reinstatement for Vasu G. Iyengar, M.D., P.A., including the name and address of the Registered Agent.

As per your discussion with Kim, Vasu G. Iyengar, M.D., P.A. relocated to a different suite and therefore a new address. At that same time they had significant changes in their office staffing. As a result of these changes, they did not receive notice of the Annual Report/Uniform Business Report for that year or for subsequent years. Evidently none of the staff were aware that the annual reports had not been filed as everyone thought someone else took care of this matter. Therefore, the Corporation has not filed the Reports in a timely manner which has resulted in the administrative dissolution of the Corporation.
