AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
ROBERT J. OROVITZ, P.A.

1. Pursuant to the provisions of Florida law, the undersigned Corporation adopts the following Amended and Restated Articles of Incorporation:

ARTICLE I
Name

The name of the corporation is ROBERT J. OROVITZ, P.A.

ARTICLE II
Duration

This corporation shall have a perpetual existence, unless dissolved according to law and, commenced on the 13th day of April, 1989.

ARTICLE III
Purpose

This corporation is organized for the sole and specific purpose of rendering professional services in the conduct of legal practice and for such other lawful purposes as are permitted under Chapter 621 of the Florida Statutes governing professional service corporations.

ARTICLE IV
Capital Stock

The Corporation is authorized to issue one hundred (100) shares of One Dollar (\$1.00) par value common stock. Twenty (20) shares shall be designated "Class A Voting Common Shares"; and Eighty (80) shares shall be designated "Class B Nonvoting Common Shares". The Class A and Class B shares shall be entitled in all respects to equal rights and privileges except that each share of Class A shall be entitled to one (1) vote and each share of Class B shall be nonvoting stock.

ARTICLE V

Principal Office; Registered Office and Agent

The street address of the principal office of this corporation is: 7765 S.W. 87th Avenue, Suite 101, Miami, Florida 33173. The street address of the registered office of this corporation is: c/o Robert J. Orovitz, 7765 S.W. 87th Avenue, Suite 101, Miami, Florida 33173.

ARTICLE VI

Board of Directors

This corporation shall have one (1) director. The number of directors may be increased or decreased from time to time by the By-laws, but shall never be less than ONE (1). The names and addresses of the directors of this corporation are:

2. The number of shares of the Corporation outstanding at the adoption was ONE HUNDRED (100), and the number of shares entitled to vote thereon was ONE HUNDRED (100).

3. The number of shares voted in favor of such Amendment was ONE HUNDRED (100), and the number of shares voted against such Amendment was none. The number of votes cast in favor of such Amendment by the Shareholders was sufficient for approval.

4. The holders of Common Shares shall exchange one (1) share of such stock for 0.2 shares of Class A Voting Shares and 0.8 shares of Class B Nonvoting Shares.

5. These Amended and Restated Articles of Incorporation were adopted and approved on the 30th day of July, 2008.

6. These Amended and Restated Articles of Incorporation shall become effective immediately upon filing with the Department of State of Florida.

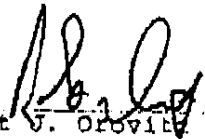
