ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF MITCHELL R. GREENBERG, D.C., P.A.

THE SECTION OF THE SE

The following provision of the Articles of Incorporation of MITCHELL GREENBERG, D.C., P.A., a Florida corporation ("Corporation"), filed with the Department of State on April 24, 1989, Charter Number K82780 be, and it is hereby, amended as shown below:

- Paragraph 1 of the Articles of Incorporation of this Corporation is amended to read in its entirety as follows:
 - "1. The name of the Corporation is MITCHELLR. GREENBERG, D.C., INC."
- Paragraph 3 of the Articles of Incorporation of this Corporation is amended by deleting it in its entirety and substituting in its place the following:
 - "3. This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act."
- Paragraph 4 of the Articles of Incorporation of this Corporation is amended by deleting the second sentence in its entirely.

The foregoing amendment was adopted by a Corporate Action by all the Directors and all the Shareholders of this Corporation, dated November 29, 2004.
