Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, whose Articles of Incorporation were approved by and filed with the Secretary of State of Florida on April 24, 1989, document number K82939, and as amended by that certain Articles of Amendment to Articles of Incorporation of Lynn Walker Wright, P.A. on June 23, 1999, document number K82939.

1. The following Second Amendment to the Articles of Incorporation was adopted by the Shareholders and the Directors of the Corporation on the 12th day of July, 1999, and the Shareholders and Directors of the Corporation have consented, authorized, and granted the use of the name "Wright, Railey & Harding, P.A." to said Corporation by Action by Consent on the 12th day of July, 1999, in the manner prescribed by the Florida General Corporation Act.

A. Article I of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE I - NAME

The name of the Corporation shall be LYNN WALKER WRIGHT, P.A.

2. The remainder of the Articles of Incorporation and all Amendments thereto, shall remain the same and except as herein amended, and shall remain in full force and effect.

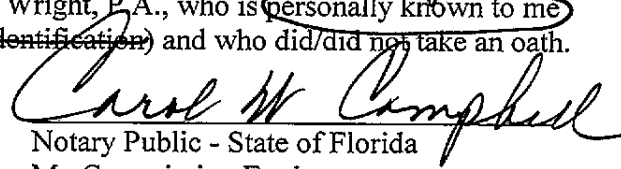
