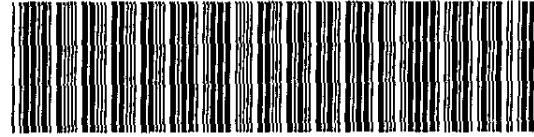



The name and address of the **officer** is **Mehrdad Khorassani, 3857 Long Grove Lane, Port Orange, FL 32119**


Article VII of the Articles of Incorporation for the corporation is hereby changed to read as follows:
