To Whom It May Concern:

Enclosed herewith please find my 2001 Uniform Business Report.

Please be advised that I am under medical care for chronic vascular migraines. Furthermore, during the preceding six months I was going through divorce proceedings which culminated in a Notice of Final Hearing on April 25, 2001 (Exhibit A). Incident to these divorce proceedings I was advised by the Fort Lauderdale Police Department to institute an Order/Injunction for Protection Against Domestic Violence (Exhibits B & C) because on numerous occasions during the first half of 2001 I had to resort to Police intervention to assist in dealing with my former spouse. My former spouse was Baker Acted for three days mandatory observation when following the divorce, she threatened to harm herself. Finally, during all this, my mother has been in hospitals and skilled nursing facilities during all of 2001. These mounting personal problems rendered me unable to fulfill, in a timely fashion, my UBR filing obligation.

However I have been incorporated since May 1, 1989. During the intervening years I have always filed my Annual Reports/UBR's on a timely basis. I therefore respectfully request that the penalties assessed incident to late filing be waived in consideration of these extenuating circumstances and in recognition of my track record of timely filings heretofore.
