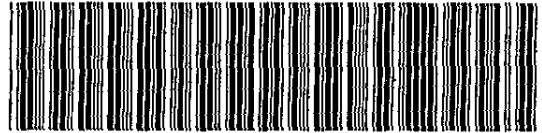



ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
INDIAN RIVER PHYSICIAN ASSOCIATES, INC.

FILED

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, Indian River Physician Associates, Inc., a Florida corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Indian River Physician Associates, Inc., a Florida Corporation.

2. The following amendment to the Articles of Incorporation was adopted unanimously by the Shareholders and Directors of the corporation pursuant to an Action Without a Meeting in the manner prescribed by the Florida General Corporation Act effective August 1, 2002: Article IV is deleted in its entirety and the following substituted in lieu thereof:

ARTICLE IV. CAPITAL STOCK. The Board of Directors is authorized to issue no more than two (2) shares of capital stock to any individual shareholder and no more than four (4) shares to any trust qualifying as a Subchapter S Trust (QSST) or an Electing Small Business Trust (ESBT), *provided*, in no event shall the total outstanding shares of the corporation exceed 1,000.


