ARTICLES OF DISSOLUTION

OF

Pursuant to Section 607.1403, Florida Statutes, Continental Utility, Inc., a Florida for profit corporation (the "Corporation"), submits the following Articles of Dissolution:

ARTICLE I

NAME

The name of the Corporation as currently filed with the Department of State is Continental Utility, Inc.

ARTICLE II

The document number of the Corporation is K95159.

ARTICLE III

The date that dissolution was authorized was December 19, 2016, and the effective dissolution is December 31, 2016.

ARTICLE IV

Dissolution was approved by the shareholders of the Corporation. The number of votes cast for dissolution was sufficient for approval.

ARTICLE V

Upon dissolution, all assets of the Company are transferred to the shareholder, Continental Country Club R. O., Inc., a Florida not for profit corporation, which include but are not limited to the reversion rights contained in the Asset Transfer and Acquisition Agreement between Company and City of Wildwood dated November 2015.
