Gentlemen:

On October 4, 2001 Dion Sharer, president of Dion's Lawn and Ornamental Pest Control, Inc., contacted our office after learning during a banking transaction that his corporation was inactive. We normally complete all federal and state forms as provided by our clients and maintain a copy of such filings in our client records. After researching Mr. Sharer's corporate files, we determined his last corporation annual report filing was for the year 1997. I immediately contacted the Division of Corporations and was told that this corporation was indeed inactive. Initially I was instructed by your office that our client should file a corporate reinstatement form along with a reinstatement fee of \$1,200.00. Further inquiry revealed that the annual reporting form for 1998 had been returned to you by the postal service. As you can see from the copy of the 1997 filing (enclosed), the mailing address had been corrected to reflect a New Port Richey post office. At that point I was advised the reinstatement fee was \$600.00, presumably because of the address correction oversight. It was suggested that this letter be included with the reinstatement form to explain the events leading to the inactive status.

We are enclosing a completed corporation reinstatement form along with our client's check in the amount of \$600.00, as instructed. Please review this information and reinstate this corporation.
