**AMENDED & RESTATED ARTICLES OF INCORPORATION
OF
DOOR CONTROL, INC.**

In compliance with the requirements of Sections 607.1003 and 607.1007 of the Florida Business Corporation Act, the undersigned hereby adopts and files the following Amended & Restated Articles of Incorporation.

**ARTICLE I
NAME**

The name of the corporation is Sycamore Holdings, Inc. (the "Corporation").

**ARTICLE II
PRINCIPAL BUSINESS ADDRESS AND MAILING ADDRESS**

**ARTICLE III

The number of shares which the Corporation shall be authorized to issue at any time is 7,500 shares of common stock having a par value of \$1.00 per share.

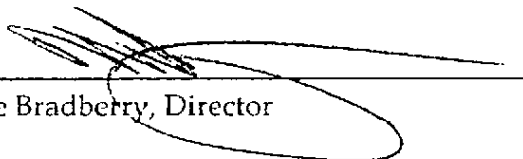
ARTICLE V REGISTERED OFFICE AND AGENT
