ARTICLES OF ORGANIZATION

OF

TORTILLERIA LA RANCHERITA, L.L.C.

A Limited Liability Company organized under Chapter 608, Florida Statutes.

The undersigned, being the initial members of a limited liability company to be formed under the Florida Limited Liability Company Act (the "Act"), hereby adopt these, the following Articles of Organization:

FIRST: The name of the limited liability company (the "Company") is:
