## ARTICLES OF ORGANIZATION OF ROYAL RECOVERY EXPEDITION 2000, LLC

The Articles of Organization following are adopted for the purpose of organizing a Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

### ARTICLE I

#### *Name and Address of Company*

The name of the limited liability company (hereinafter referred to as the "Company") is Royal Recovery Expedition 2000, LLC. The Company's street and mailing address is 200 Greene Street, Key West, Florida 33040.

### ARTICLE II

#### *Commencement and Duration of Company*

The Company shall exist from the date of filing these Articles with the Florida Department of State until the occurrence of any of the events specified in Section 608.441, unless continued by the unanimous consent of all the remaining members.

### ARTICLE III

#### *Management*

The following person shall serve as the Company's initial manager and shall serve until the first annual meeting of membership or until his successor is elected and qualified:

#### ARTICLE V

##### *Termination of Membership*

If a member of the Company dies, retires, resigns, is expelled, declared insane, becomes bankrupt, is dissolved or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.

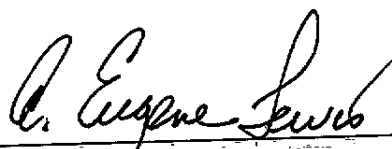

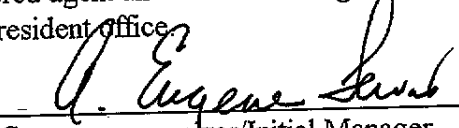

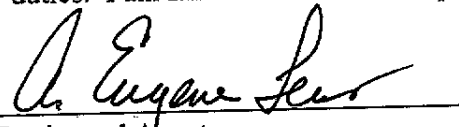
