ARTICLES OF ORGANIZATION

OF

THE HERRING LAND AND TIMBER LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Act, do hereby adopt the following Articles of Organization.

ARTICLE 1.0

The name of the Limited Liability Company shall be The Herring Land and Timber LLC.

ARTICLE 2.0

The period of its duration may not exceed 30 years from the date of filing with the Department of State.

ARTICLE 3.0

The purpose for which the Limited Liability Company is organized shall be to own and manage real property and timber and the engagement of any legal business or investment activity as the Managers may from time to time determine.

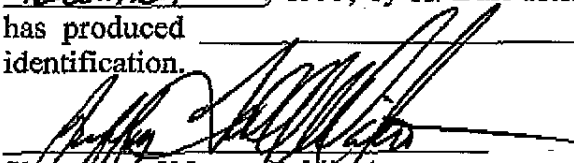

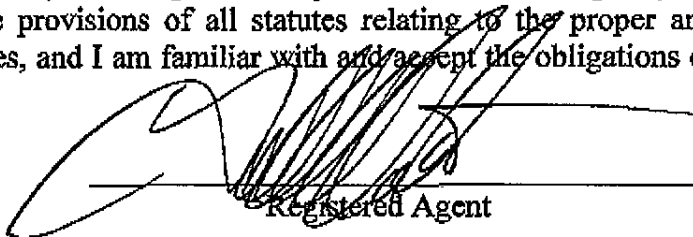
