# ARTICLES OF ORGANIZATION

## OF

### ASTRO COMPUTERS, L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE 1 - NAME

The name of the limited liability company shall be **ASTRO COMPUTERS, L.C.**, ("Company").

#### ARTICLE 2 - ADDRESS

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.


