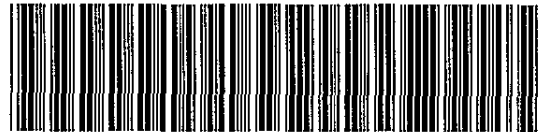


**ARTICLE I**
