ARTICLES OF ORGANIZATION FOR

APARTMENT SWEET APARTMENT, L.L.C.

Following Chapter 608 of the Florida Statutes, the undersigned does hereby submit these Articles Organization for forming a Florida Limited Liability Company.

Article 1: Name and Principal Office

Article 2: Duration

The duration of the limited liability company is perpetual.
