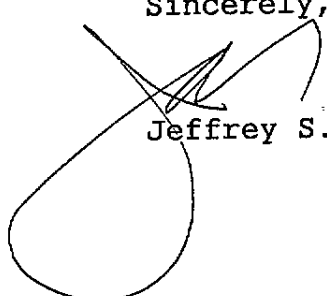

**ARTICLE VII**

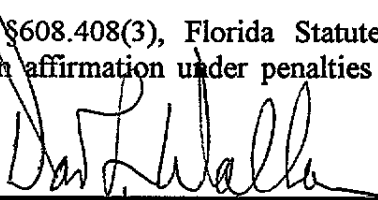
**MANAGEMENT PROVISIONS**
