**Articles of Organization for Sculptors of Space, L.L.C.
a Florida Limited Liability Company (FS § 608.407)**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:


1. Name. The name of this company shall be Sculptors of Space, L.L.C.

3. Duration/Continuation. 8. Management of Company. The business of the Company shall be managed by the Managing Members. The names and addresses of the Managing Member is set forth above in Article 4.


