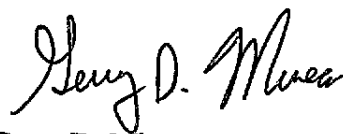

ARTICLES OF ORGANIZATION
OF
TURF TIME LLC.

The undersigned Member adopts the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

ARTICLE I.
NAME OF COMPANY

The name of the limited liability company is TURF TIME LLC. (the "Company").

ARTICLE II.
MAILING ADDRESS OF COMPANY
