**ARTICLES OF ORGANIZATION  
OF  
APDIVERS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be APDIVERS, LLC ("Company"). The principal place of business of the Company in Florida shall be 3551 Heron Drive South, Jacksonville Beach, FL 32250. The mailing address of the business shall be: 3551 Heron Drive South, Jacksonville Beach, FL 32250.

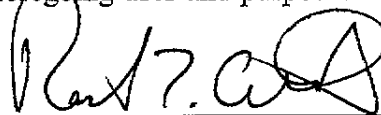

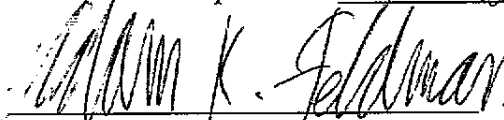
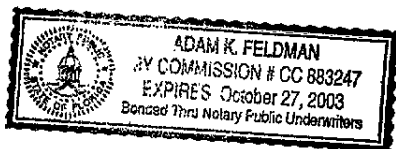
