ARTICLES OF ORGANIZATION

OF

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. NAME.

The name of the Limited Liability Company is:

NAT'S IRRIGATION & LANDSCAPING, LC (The "Company").

2. PERIOD OF DURATION.

The period of duration of the Limited Liability Company shall be from the date of filing until the first to occur of the following:

- (i) Thirty (30) years from the date of filing of these Articles of Organization with the Department of State of Florida, or
- (ii) Dissolution of the Company pursuant to provisions of the Florida Limited Liability Company Act, and the Company's Regulations.

3. PURPOSE.

The purpose for which the Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Company shall have all of the powers vested in a Limited Liability Company organized and existing by virtue of such laws.

4. ADDRESS OF PRINCIPAL OFFICE.

Nutek Slomowicz 1375 Lake Drive, Casselberry, Florida 32707.

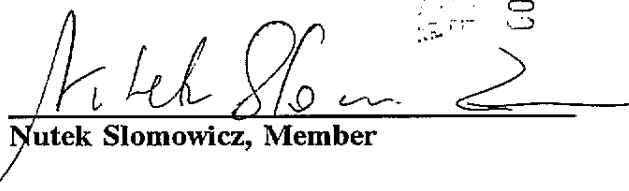
6. **CONTINUITY OF BUSINESS.**

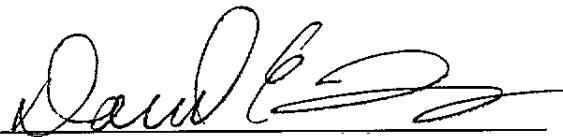
